**THE REGULAR MEETING** of the Town Council of Upton, Wyoming was held at 7:00 p.m. on Tuesday, January 8, 2019 at the Upton City Hall located at 725 2<sup>nd</sup> Street in Upton, Wyoming.

COUNCIL MEMBER NORMAN MOVED, COUNCIL MEMBER STIRMEL SECONDED a motion to approve the second reading of Ordinance No. 1, Series 2019: AN ORDINANCE AMDENDING THE SECTION 2.08.020, UPTON MUNICIPAL CODE, UPDATING THE BOND AMOUNT REQUIREMENTS FOR ANY PERSONS WITH CUSTODY OF TOWN OF UPTON FUNDS. Superintendent Lindstrom gave a brief update that the 3<sup>rd</sup> Street Project would be going out to bid.

COUNCIL MEMBER NORMAN MOVED, COUNCIL MEMBER STIRMEL SECONDED a motion to approve the Conflict of Interest policy. All ayes, MOTION CARRIED.

COUNCIL MEMBER STIRMEL MOVED, COUNCIL MEMBER NORMAN SECONDED a motion to table the Unclaimed Property and Special Events policies until the February meeting for further review. All ayes, MOTION CARRIED.

COUNCIL MEMBER STIRMEL MOVED, COUNCIL MEMBER NORMAN SECONDED a motion to approve a request from the Chamber of Commerce to have alcohol for their installation banquet at the Community Center on Saturday, January 26, 2019. All ayes, MOTION CARRIED.

Chief Bridge gave her report and noted many positive contacts for the month of December. Unofficial Minutes of the Regular Meeting January 8, 2019

Chief Strong's report was reviewed.

Superintendent Lindstrom gave his report. The Town of Upton had been approved for a USDA Search Grant in the amount of \$30,000.00, prior to the federal government shutdown, and will wait for an official letter before proceeding.

Clerk/Treasurer Millar reported that the water fund was slightly behind anticipated budget numbers at the half year, and that approximately \$6,497.00 in utility accounts were past due as of the end of the year. Attorney Hughes discussed a collection list he had been provided and suggested that the amounts under his fees could be written off instead of pursued at a loss. Council Member Joe Watt asked about using small claims court filings to collect on the past due accounts. He will stop in at City Hall to explain the process. Attorney Hughes and Clerk/Treasurer Millar will work on the collections list letters as well.

Attorney Hughes reported to the Council regarding a letter received from Michael's Construction about the remaining retainage amount that is to be used for the capstone replacement. He and Superintendent Lindstrom will draft a response letter detailing the decision to keep those funds.

Mayor Beck updated the Council that the Wyoming Game and Fish contract to stock the pond at the golf course is still out for final signatures and that they were interested in the possibility of using piped water from Well No. 6 to aerate the pond. The use of Well No. 6 has been previously discussed as a watering source for the golf course. He also let the Council know that a presentation on behalf of the Town had been made to Governor Mead and Auditor Cloud to show appreciation for the support given to the Town over their tenure.

There being no further business, COUNCIL MEMBER DAVID WATT MOVED, COUNCIL MEMBER STIRMEL SECONDED a motion to adjourn. All ayes, MOTION CARRIED. The meeting adjourned at 7:42 p.m.
