

ORDINANCE NO. 2, SERIES 2019

AN ORDINANCE AMENDING SECTIONS 10.16.035 AND 10.16.040 AND ADDING SECTION 10.16.033 OF THE UPTON MUNICIPAL CODE FOR SNOW REMOVAL

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF UPTON, WESTON COUNTY, WYOMING

1. Section 10.16.033 shall be added to the Upton Municipal Code and read as follows:

10.16.033 Authority of the Superintendent The Superintendent or his assigned agent shall have the authority, during extreme snow removal circumstances, to close any street or portion of street which is under the jurisdiction of the Town to all traffic and parking, if necessary, for public safety and efficient removal of snow.

2. Section 10.16.035 of the Upton Municipal Code is amended to read as follows:

Snow Removal

- A. No person shall park, place or leave any vehicle, trailer, camper or RV, etc. on any street after a snow event of 3 inches or more. Items must be moved off the streets by 6:00 a.m.
- B. Any motor vehicle or towed vehicle parked upon a street or alley at a time when such parking is prohibited may be removed from the street or alley by the Town or its designee at the expense of the registered owner of the motor vehicle or towed vehicle. The registered owner of any motor vehicle or towed vehicle which has been towed or impounded shall be required to pay all towing and storage fees in addition to penalties.
- C. It shall be unlawful for any person, or operator of any vehicle, to interfere with or obstruct, or cause interference with or obstruction, of the snow removal operations undertaken by the Town and its employees. It shall also be unlawful for any person to operate any vehicle or equipment in a manner not reasonable or prudent, thereby creating damage or a safety risk in relation to snow removal operations.
- D. It shall be unlawful for any person to place snow from private or commercial property on any public street.
- E. It shall be unlawful to pile snow in any alleyway at any time.
- F. The Town will not plow snow from private property and will not open private driveways whether closed by the Town street plowing or other means.
- G. Trash carts must be removed after trash collection has been completed.

3. Section 10.16.040 of the Upton Municipal Code is amended to read as follows:

VIOLATION -PENALTY.

Violation or any of the provisions of this chapter is a misdemeanor and every person cited for a violation of any of this chapter shall:

- (i) For a first citation, be punishable by a fine of not more than \$100.00 (one hundred dollars);
- (ii) For a second citation of the same offense within 1 (one) year thereafter, be punishable by a fine of not more than \$300.00 (three hundred dollars); and
- (iii) For a third or subsequent citation of the same offense within 1 (one) year thereafter, be punishable by a fine of not more than \$750.00 (seven hundred fifty dollars).

ADOPTION OF THIS ORDINANCE BY EMERGENCY

This ordinance shall be adopted by emergency pursuant to the provisions of Wyoming Statute §15-1-115 and shall take effect immediately upon proclamation by the Mayor.
