RESOLUTION NO. 9, 2021 A RESOLUTION REQUESTING EXPENDITURE OF AMERICAN RESCUE PLAN ACT FUNDS ON BEHALF OF THE GOVERNING BODY FOR THE TOWN OF UPTON, WESTON COUNTY, WYOMING

WHEREAS, pursuant to the applicable federal law and released guidance regarding the American Rescue Plan Act funding received by the Town of Upton, Wyoming as a "Non-Entitlement Unit" in the amount of \$91,575.43 on June 25, 2021 the funds must be expended only on items that fall into the currently released guidance; and

WHEREAS, a second tranche of funding in the amount of \$91,575.43 is expected to be received in June 2022 for a total of \$183,150.86 in funding; and

WHEREAS, the Town of Upton has several eligible expenditures that conform with the released guidance that include but are not limited to the following:

- Software additions that will help create efficiencies immediately upon deployment and exponentially in the future in the amount of approximately \$13,510.00 through the purchase of Budget Preparation, Service Orders & Remote Service Orders, Utility Billing Automated Meter Reading Interface, UB Email Bills and UB Rate Analysis software modules from Black Mountain Software.
- 2. Utility Line Locating Devices in the amount of approximately \$3,000.00 from Sewerin Technologies.
- 3. An upgraded touch meter reading system that includes four Sensus Touch Read tablets which work in conjunction with the AMR Reading Interface from BMS to create further efficiencies in the organization in the amount of approximately \$14,547.42 from Ferguson Waterworks Meter & Automation Group.
- 4. A leak locating tool in the amount of approximately \$17,649.00 from Sewerin Technologies that will assist in more quickly locating and assessing leaks in both water and sanitary sewer lines.
- 5. Large generator at the lagoon ponds in the amount of approximately \$19,095.00 from Electric Direct Generators.
- 6. The purchase and installation of a Mission SCADA Integration system for more accurate and remote capability in monitoring the Town's water system in the amount of approximately \$13,686.40.
- 7. An estimated \$10,000.00 in broadband infrastructure development investment.
- 8. An estimated \$20,000.00 designated toward the development of a Capital Improvement Plan for the Town of Upton that will integrate other planning documents already in progress.
- 9. The purchase and installation of generators at water wells to include the necessary power supply in the amount of approximately \$91,663.49; and

WHEREAS, the above stated plan of expenditures make efficient and adequate use of 100% of the funds received before the December 2024 deadline and that all funds will be expended or returned before December 2026 as required by federal law and released guidance to date; and

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE TOWN OF UPTON, WYOMING that the funds received from the American Rescue Plan Act will only be expended on properly approved items brought before the governing body of the Town of Upton prior to expenditure and that all reporting requirements shall be met in accordance with federal law and released guidance regarding the ARPA funds.
