## Town of Upton Regular Town Council Meeting December 12, 2023

**THE REGULAR MEETING** of the Town Council of Upton, Wyoming, was called to order at 7:00 p.m. on Tuesday, December 12, 2023, at the Upton City Hall located at 725 2<sup>nd</sup> Street in Upton, Wyoming.

Present: Mayor Nicholas Trandahl, Council Members Joe Watt, Rick Rothleutner, and Justin Norman. Council Member Tiffany McMillan was absent. COUNCIL MEMBER NORMAN MOVED, COUNCIL MEMBER ROTHLEUTNER SECONDED a motion to approve the consent agenda which included the minutes from the November 7, 2023 regular meeting as published, minutes from the November 7, 2023 special meeting, claims paid for December to date, and claims paid in November (utility payments, payroll, approved grant/loan expenses). ## **CLAIMS DENIED: NONE**

Abbey Hagerman with ClingerHagerman called in to give the Town of Upton's FYE 2023 Financial Statement review.

Clerk/Treasurer Millar reported that the advertisement for consultant selection for the Upton Municipal Airport was ready and would begin publication in the next week.

Council Member McMillan, liaison to the Upton Golf Association, had sent a year-to-date profit and loss statement for the Cedar Pines Golf Course.

COUNCIL MEMBER WATT MOVED, COUNCIL MEMBER ROTHLEUTNER SECONDED a motion to approve Ordinance No. 4, Series 2023 entitled: AN ORDINANCE AMENDING PORTIONS OF CHAPTER 10 IN SECTION 10.32 OF THE UPTON MUNICIPAL CODE. Mr. Danens thanked the council and asked if he would be able to bring his tractor or a trailer to his residence for tire repairs on a temporary permitted basis. Mr. Allen expressed concern for the restrictions regarding time limits and vehicle class size for permits allowed. Mr. Alishouse expressed concern over the security of his work vehicle being parked away from his home. Comments were addressed. A friendly amendment was posed to strike unnecessary language in section 10.32.020 "unless exempted", to strike redundant language in section 10.32.030 "from First Street easterly to Ash Street", to alter language in section 10.32.050 insert "and maintenance" after streets, delete "a privilege", insert " of paramount importance", and also in section 10.32.030 insert "the portion of Aspen Street southerly to Highway 16; the portion of Whitetail Street easterly to Highway 116;". The amendment was accepted by the motion maker and second. All ayes, MOTION CARRIED. A copy of the final ordinance will be published in full in the *Weston County Gazette* and available online at <a href="https://www.townofupton.com">www.townofupton.com</a>.

Mayor Trandahl opened the budget amendment hearing at 7:25 p.m. and asked for comments. There being none, the hearing was closed at 7:26 p.m.

COUNCIL MEMBER NORMAN MOVED, COUNCIL MEMBER WATT SECONDED a motion to approve and amendment to the Town of Upton's 2023-2024 budget in the following particulars:

Increase the General Fund Budget by \$43,180.00 by budgeting \$29,430.00 from the ARPA Reserve, \$12,500.00 from Grant Revenue awarded from the Wyoming Energy Authority and \$1,250.00 from General Fund Cash Reserves. These monies will be used to pay for a color multi-machine in the amount of \$5,626.50, for new equipment in the amount of \$10,145.50, and for equipment repairs in the amount of \$13,658.34 as eligible expenditures per US Treasury guidance for ARPA funds in the total amount of \$29,430.34. Special Note: The remaining funds in the ARPA Reserve will be transferred to the Capital Improvement Reserve, split between water and sewer funds. The remaining funds for this amendment will be used to replace lighting in the Upton Community Center with LED upgrades as per the grant agreement with the Wyoming Energy Authority dated 11/07/2023 that includes \$12,500.00 in grant funds to be received and \$1,250.00 in local matching funds. All ayes, MOTION CARRIED.

COUNCIL MEMBER ROTHLEUTNER MOVED, COUNCIL MEMBER NORMAN SECONDED a motion to approve the updated Weston County Emergency Operations Plans. All ayes, MOTION CARRIED.

COUNCIL MEMBER WATT MOVED, COUNCIL MEMBER NORMAN SECONDED a motion to approve Ordinance No. 5, Series 2023 entitled: AN ORDINANCE VACATING ALL OF HALF STREET IN THE NEIMAN ADDITION, TOWN OF UPTON, WYOMING. All ayes, MOTION CARRIED.

Officer Larson gave the Upton Police Department report that had been submitted by Chief Bridge.
