

RESOLUTION NO. 5, 2024

A RESOLUTION OF THE TOWN COUNCIL OF UPTON, WESTON COUNTY,
WYOMING ADOPTING UTILITY RATE AMOUNT INCREASES FOR THE FISCAL
YEAR 2024-2025

WHEREAS, the Town Council of Upton, Weston County, Wyoming has found it necessary to update rates, deposits and fees associated with enterprise funds; and

WHEREAS, the Town Council of Upton, Weston County, Wyoming imposes fees to recoup the costs of all services resulting from all enterprise funds expenditures; and

WHEREAS, the Town Council of Upton, Weston County, Wyoming is required to balance the budget and all enterprise funds must be self sustaining; and

NOW, THEREFORE BE IT RESOLVED by the Town Council of Upton, Weston County, Wyoming that rate increases in the following particulars will become effective July 1, 2024:


1. The base rate for water access shall increase approximately 7% or \$1.46 from \$19.00 to \$20.46 per month.
 2. The rate for each 1,000 gallons of water used shall increase approximately 5% or \$0.25 from \$5.00 to \$5.25 per thousand for all user types other than those listed #3.
 3. The rate for each 1,000 gallons of water used shall increase approximately 5% or \$0.50 from \$10.00 to \$10.50 for out-of-city-limits users.
 4. A Fire Suppression rate shall be established at a flat fee of \$15.00 per month per system with a corresponding out-of-city-limits user rate of \$30.00 per month.
 5. The fixed rate for residential sewer users shall increase approximately 8% or \$2.12 from \$24.00 to \$26.12 per month.
 6. The fixed rate for commercial tier I sewer users shall increase approximately 4% or \$1.12 from \$26.00 to \$27.12 per month.
 7. The rate for any commercial-out tier I sewer users shall increase approximately 4% or \$2.24 from \$52.00 per month to \$54.24 per month for out-of-city-limit sewer users in tier I.
 8. The fixed rate for commercial tier II sewer users shall increase approximately 6% or \$6.00 from \$87.00 to \$93.00 per month.
 9. The rate for commercial tier II sewer users shall increase approximately 9% or \$16.00 per month from \$170.00 to \$186.00 for out-of-city-limit sewer users in tier II.
 10. The rate for Landfill Closure shall increase approximately 20% or \$0.50 per user, per container, per month from \$2.00 to \$2.50 for each 96-gallon container or equivalent thereof.
 11. The rate for recycling/cardboard compactor shall increase approximately 50% or \$0.50 from \$0.50 per month to \$1.00 per month for all customers.
- A minimum residential utility bill with 1,000 gallons of water usage will increase approximately 5% from \$87.50 to \$92.33 per month.
