RESOLUTION NO. 6, 2025

A RESOLUTION OF THE TOWN COUNCIL OF UPTON, WESTON COUNTY, WYOMING ADOPTING UTILITY RATE AMOUNT INCREASES FOR THE FISCAL YEAR 2025-2026

WHEREAS, the Town Council of Upton, Weston County, Wyoming has found it necessary to update rates, deposits and fees associated with enterprise funds; and

WHEREAS, the Town Council of Upton, Weston County, Wyoming imposes fees to recoup the costs of all services resulting from all enterprise funds expenditures; and

WHEREAS, the Town Council of Upton, Weston County, Wyoming is required to balance the budget and all enterprise funds must be self sustaining; and

NOW, THEREFORE BE IT RESOLVED by the Town Council of Upton, Weston County, Wyoming that rate increases in the following particulars will become effective July 1, 2025:

- 1. The base rate for water access shall increase approximately 3% or \$0.54 from \$20.46 to \$21.00 per month.
- 2. The rate for each 1,000 gallons of water used shall increase approximately 5% or \$0.25 from \$5.25 to \$5.50 per thousand for all user types other than those listed #3.
- 3. The rate for each 1,000 gallons of water used shall increase approximately 5% or \$0.50 from \$10.50 to \$11.00 for out-of-city-limits users.
- 4. A Fire Suppression rate shall remain the same at a flat fee of \$15.00 per month per system with a corresponding out-of-city-limits user rate of \$30.00 per month.
- 5. The fixed rate for residential sewer users shall increase approximately 1% or \$0.38 from \$26.12 to \$26.50 per month.
- 6. The fixed rate for commercial tier I sewer users shall increase approximately 1% or \$1.12 from \$27.12 to \$27.50 per month.
- 7. The rate for any commercial-out tier I sewer users shall increase approximately 1% or \$2.24 from \$54.24 per month to \$55.00 per month for out-of-city-limit sewer users in tier I.
- 8. The fixed rate for commercial tier II sewer users shall increase approximately 1% or \$1.00 from \$93.00 to \$94.00 per month.
- 9. The rate for commercial tier II sewer users shall increase approximately 1% or \$2.00 per month from \$186.00 to \$188.00 for out-of-city-limit sewer users in tier II.
- 10. The fixed rate for industrial sewer users, both in town and out-of-town, shall be re-evaluated and set at a later date.
- 11. No rate changes are proposed for the Sanitation/Landfill at this time. Those funds will be monitored closely as the Town navigates closure of the Upton Landfill

A minimum residential utility bill with 1,000 gallons of water usage will increase approximately 1% from \$92.33 to \$93.50 per month.
